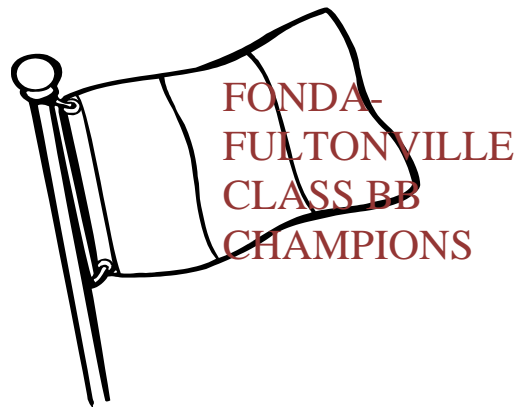
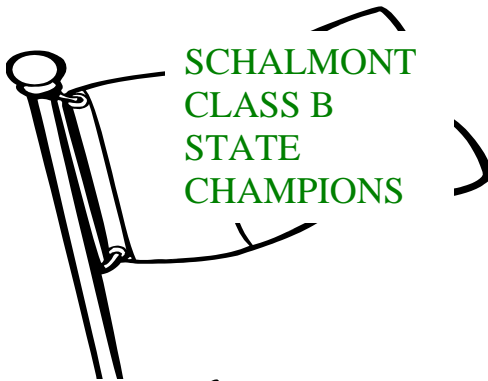
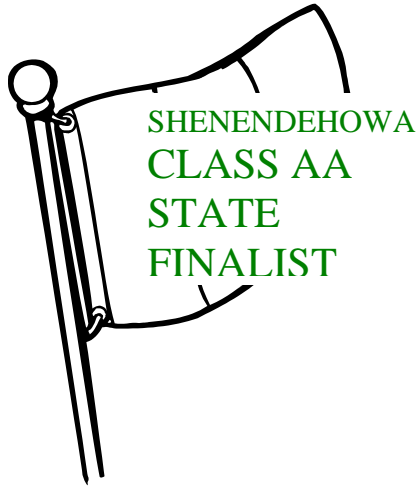

2. Coaches need to bring 75-100 copies of their **TYPED ROSTER (PAGE 19)** to their semi-final and championship games.
3. It is the responsibility of the winning coach in all sectional games to notify Rico Frese of the final score and to call in results to the media. This needs to be done ASAP after the game.
4. For all semi-final and championship games teams will be given 10 minutes of infield/outfield pre-game warm-up. The game mound is NOT available during pre-game warm-up.
5. Each team is to supply the officials with a dozen (12) top grade game balls.

IMPORTANT INFORMATION FOR ALL COACHES
2015 FORMAT AND REQUIREMENTS FOR PARTICIPATION IN
THE SECTION 2 BASEBALL TOURNAMENT

Philosophy:

The Section 2 Baseball Committee is committed to providing our member schools with a high quality sectional tournament. Our tournament will produce 5 classification champions with the best opportunity to compete for a state championship.

The Section 2 Baseball Committee believes the emphasis, for qualifying criteria, should be placed on league competition. The committee understands the importance of non-league contests and recognizes the different purposes as well as the rivalry and competitive nature of some of these non-league contests.

This philosophy will serve our tournament well while maintaining the integrity of the eight leagues that make up our section.

QUALIFYING CRITERIA:

1. Each Class (AA, A, B, C, D) will have a minimum of 8 schools in the tournament.
2. Any Section 2 baseball team achieving a league winning percentage of .500 or better will automatically qualify for the tournament. (Minimum of 10 league games are required for consideration), (Must complete league schedule and have league president sign off as to why league schedule was not completed; which may effect its seeding).
3. Sub .500 teams (league record) may be placed into the tournament under the following conditions:

A. Special Consideration - Any school which plays half or more of their league games against larger classification schools.

These schools will be awarded 2 wins for each league victory against a larger classification school. If the two for one wins formula, brings the number of "wins" to 50% of the number of scheduled league games that school will be placed into the tournament. The seeding of these Special Consideration qualifiers will be determined by the baseball committee.

Suburban Council	16 league games	50% = 8 "wins"
WASAREN	14 league games	50% = 7 "wins"
Western Athletic Council	16 league games	50% = 8 "wins"

QUALIFYING CRITERIA CONTINUED:

B. If using this formula there are still fewer than 8 schools in a class the baseball committee will fill the bracket to 8 schools using the following criteria. Please note the following will be taken into consideration collectively, not in any ranked order.

- a) Completed record sheets must be received by class and league chairmen and be available at the seeding meeting
- b) Record of games played up in class
- c) Record against other qualifying schools
- d) Recommendation of League Chairman

C. A school which does not qualify for the sectional tournament based on the qualifying criteria, may petition the committee for entry into the sectional tournament. The petition must be in writing, received by the league chairman, Class chairman and the coordinator by noon Friday, May 15, 2015. The petition must be signed by both the coach and the athletic director.

The higher seed will be the home team, (or have the choice of home or visitor), and choice of dug out in all rounds. In the case of rain dates, after the first round, home sites of the higher seeds may be used.

DETAILS OF BASEBALL SECTIONAL PLAY EACH COACH IS RESPONSIBLE FOR ALL WRITTEN DETAILS

1. The team with the higher seed will be the home team in all rounds. Currently the opening and quarterfinal rounds are played on the home field of the higher seed. In the case of inclement weather schools will be given the opportunity to prepare their field. If the field is unplayable for any reason, and the field of their opponent is playable then the game will be moved to the home field of their opponent. If neither field is playable the schools are permitted to agree upon a facility to move the game to; if they are unsuccessful the Baseball Committee will assign a field..
2. If there is a split classification a toss of a coin by the site chairman decides the home team and the official scorebook for the playoff game.
3. BATTING PRACTICE may be taken at your field only. Batting practice will only be offered at neutral sites if both teams have equal opportunity.
4. Each team will be allowed 10 minutes of infield/outfield practice prior to the games. This will begin 35 minutes prior to the start of the game. Home team will go first.
5. Each team is to supply the officials with a dozen (12) top grade game balls.
6. NATIONAL FEDERATION RULES are to be followed. The National Federation rules have been adopted by NYSPHSAA and Section 2 as the official rules.
7. The winning team's coach is responsible for reporting the score to the Section 2 Baseball Chairman, and local media as soon after the game as possible.

DETAILS OF BASEBALL SECTIONAL PLAY
EACH COACH IS RESPONSIBLE FOR ALL WRITTEN DETAILS
(CONTINUED)

8. NO protest in sectional play. Interpretation of a rule will be settled at the site by the officials in charge. All coaches are urged to have a rule book with them. If no rule book is available, umpires will make the final ruling.
9. Line-up cards will be official. By rule all substitutes are not required to be listed. As a courtesy to the officials & opponents please list all players, starters and substitutes.
10. In the case of inclement or threatening weather, the site chairman will decide if a game will start.
11. IT IS YOUR RESPONSIBILITY TO FAX YOUR SCHEDULE WITH W'S & L'S AND YOUR ROSTER TO YOUR LEAGUE AND CLASS CHAIRMEN BY FRIDAY, MAY 15, 2015. WE WILL NOT CALL YOU. Be sure that you have indicated league and non-league games. The phone and fax numbers of the Class and League Chairmen are provided on pages 3 and 4. Coaches who fail to provide this information should understand that without this information, their team may receive a lower seed.
12. The Baseball Committee and Section 2 would appreciate everyone's cooperation on the use of your diamond for sectional play. Include with your request for participation in the 2014 Sectional Tournament your willingness to host a game. If requested to serve as a host site we would ask you to line the field, provide bases and benches.
13. If your school cannot play on Sunday this must be submitted in writing to Section Baseball Chairman prior to Monday May 18,2015.
14. PLEASE DO NOT SCHEDULE CONFLICTING EVENTS ON SECTIONAL PLAYING DATES UNLESS YOU ARE WILLING TO CHANGE THESE EVENTS.
15. **Please Announce in School** – Admission to the semi-finals and final tournament games will be **\$6.00 for everyone**. One ticket is good for all day. **All other games are \$3.00**. Please notify your fans of these charges.
16. It is the expectation that each school participating in sectional games will have a faculty supervisor in attendance at all games to assist with security. This individual is to check in with the site director upon arrival.
17. Coaches are requested to bring 75-100 copies of their **TYPED ROSTER (PAGE 20)** to their semi-final and championship games.
18. Starting time for sectional games played on a school day will be 4:00 PM. Schools with lighted facilities shall have the right to establish the starting time of 7:00 PM. Permission will be granted by the baseball coordinator unless the visiting school has a previously scheduled school event.
19. Each school will be responsible for providing medical/training personnel at each sectional game. **SECTIONAL GAMES, TIMES, DATES, WILL NOT BE CHANGED FOR CONFLICTING EVENTS, PROMS, SENIOR TRIPS, ETC.**

Receipts must be turned in from each game.

Schools hosting a sectional opening round or quarterfinal tournament game are required to choose one of the following options:

1. Set up a gate and charge a \$3.00 admission.
2. Take a collection soliciting donations from all fans in attendance.
3. In lieu of setting up a gate or a collection the host school may opt to pay for that game's umpires by **SCHOOL VOUCHER*****

*****If option #3 is chosen it is imperative that the Section 2 Baseball Coordinator, be notified to prevent a duplicate payment being made.**

Schools that fail to turn in a financial report will be denied a home game in future sectional tournaments. Follow the procedures in the Section 2 handbook for turning in the funds to Section 2. **Also, send the Baseball Coordinator copies of all claims and income/expense reports.**

SCRIMMAGE - DEFINITION

A baseball scrimmage must include free substitutions and lineup cards will not be exchanged.

Scrimmages must also include one or more of the following:

1. Play six (6) outs per half inning (example - 3 outs clear the field/ 3 more outs).
2. Batting order must be altered or modified to include more batters than rules permit.
3. Start with a runner(s) on base with a predetermined situation for at least two (2) full innings.

GAME ENDING PROCEDURES –TIED/SUSPENDED GAMES

In all section 2 baseball games, as well as in the state tournament the following game ending procedures will be in effect. An official game consists of five (5) or four and a half (4 1/2) innings if the home team is ahead. Seven (7) innings do not have to be played.

If the game is not an official game, or has progressed far enough to be an official game but the score is tied*, the game will be a suspended game and continued from the point of suspension with the same line-up, subject to the rules of the game.

*If the game has progressed beyond the point of an official game and the visitors half inning has not been completed, (or the home team's half inning if they are behind) we will revert back to the last completed inning to determine if we have a winner or a tied and therefore suspended game. If it is a tied-suspended game it will be picked up from the point of suspension, with the same line-up subject to the rules of the game.

N.Y.S.P.H.S.A.A. BASEBALL PITCHING RULE

A pitcher may pitch in a maximum of twelve (12) innings in one (1) day but no more than eighteen (18) innings in any six (6) consecutive day period. Delivery of one (1) pitch constitutes having pitched in an inning. If he pitches in eight (8) or more innings in a day, he must have two (2) nights' rests before he can pitch again. Any violation of the rule will be considered in the same light as a school using an ineligible player. The game will be forfeited.

N.Y.S.P.H.S.A.A. BASEBALL THUNDER & LIGHTNING RULE

Thunder and lightning necessitates that contests be suspended. The occurrence of thunder and/or lightning is not subject to interpretation or discussion – thunder is thunder, lightning is lightning.

* With your site administrator, set up a plan for shelter prior to the start of any contest.

When thunder is heard and/or lightning is seen, the following procedures should be adhered to:

- A. Suspend play and direct participants to go to a shelter, a building normally occupied by the public or if a building is not available, participants should go inside a vehicle with a metal top (e.g. bus, van, car).
- B. Do not permit people to stand under or near a tree, and have all stay away from poles, antennas, towers and underground watering systems.
- C. After thunder and/or lightning have left the area, wait approximately 30 minutes after the last boom is heard or strike is seen before resuming play or competition.

If thunder or lightning continues after 30 minutes, and play is not resumed then the rules of that particular sport shall determine whether the contest is official or must be resumed at a later date.
