LETTER OF INTENT DUE DATES 2015-16

It is the responsibility of the ATHLETIC DIRECTOR at EACH SCHOOL to see that a Letter of Intent is signed by the appropriate school officials and is received by the Section 2 Executive Director at the beginning of the school year. This is ONE LETTER PER SCHOOL and is NOT SPORT SPECIFIC.

If your school chooses NOT TO PARTICIPATE in Sectional competition, your Athletic Director must contact your LEAGUE REPRESENTATIVE AND TOM HUSSER prior to the Sectional Seeding Meeting.

Sectional competition is determined by your school's classification. The Section 2 Girls' Soccer Committee reserves the right to use its discretion during the selection and pairing process for Sectionals. The following criteria for the selection and pairing process have been developed by the Sectional Committee. These criteria will be considered for the seeding process:

- All seeds will be at the discretion of the Committee and the final seeding placement will be approved by vote of the Committee.
- League and non-league records will be given first consideration for seeding. Strength of schedule will be considered when seeding.
- Head to head competition will be given consideration for determining placement.
- Prior history in Sectional competition may be considered for determining placement.

LETTER OF INTENT PROCEDURES

The following procedures regarding letters of intent for sectional competition was approved by the Section II Athletic Council of June 8, 1988.

A. Letter of Intent

1. Shall be a standard letter for all sports.
2. The standard letter of intent shall be included annually in the Section II Directory. It shall be the responsibility of each school's athletic director to make copies of this form and send to all appropriate sport chairperson by the designated due dates. A list of all sports chairpersons, addresses, and due dates for each sport shall be included in the directory.

3. It will be required that all schools send the letter of intent by the required due date in order to be eligible to participate in the sectional tournament.
4. The required due date for each sport should be no earlier than three (3) weeks prior to the beginning of sectionals in that sport. The sports chairperson shall set the due date. A five-day grace period should be built in for follow-up by league sports chairpersons.
5. A school, which has submitted a letter of intent, may choose to withdraw from the sectional tournament.
 - A. For sports for which pairing are established, upon notification of the sports chairperson or league representatives by the principal or athletic director **prior** to the seeding meeting for that sport.
 - B. For sports for which no pairing are established, upon notification of the sports chairperson or league representatives by the principal or athletic director **at least 48 hours prior** to the start of sectional competition.
6. If a school attempts to withdraw from a tournament subsequent to these deadlines, the sports chairperson or his representative shall notify the principal of the offending school and warn of probable sanction.
7. Penalties for withdrawal from a tournament subsequent to the seeding meeting or 48 hours deadline, unless extreme extenuating circumstances can be demonstrated such as: team training violations, team sickness, act of God or other emergency. First offense in a sport: \$250.00 fine levied against the school payable to Section II. Second offense in a sport (or failure to pay fine): Ineligible to participate in the sectionals for that sport for the following year.

B. Intent to continue in the Tournament

1. Any school that commits itself to the Sectional Tournament implies that it will continue in the tournament until the school is eliminated. This includes the Regionals and State Tournaments to CONCLUSION.
2. Failure to abide by the above will result in that school forfeiting its right to participate in the Section II Tournament in that activity for the following year and a \$250.00 fine payable to Section II.

C. Board of Inquiry

Any school wishing to question any penalties assessed according to these regulations should address a letter to the President of Section II. A board of inquiry will be appointed by the President, consisting of:

1. The Section II President
2. Sports Chairperson involved
3. League president of the school involved (unless connected with the protesting school, then alternate should be appointed).
4. Two at-large members for the Athletic Council

The board of inquiry may uphold the penalty as assessed or overturn the penalty.

The ruling of the board of inquiry may be appealed to the Section II Athletic Council and may be reversed by a two-thirds vote of the council.

SECTION II

GIRL'S SOCCER SECTIONAL COMMITTEE FORMAT

The committee is comprised of the Girl's Section II Soccer Sport Chairperson, League Representatives and on invitation interested people in an advisory capacity.

CONSIDERATIONS FOR QUALIFYING

1. A minimum of eight (8) games must be played.
2. The games must be on interscholastic and varsity level.
3. A letter of interest must be filed with the Girl's Section II Soccer Chairperson by October 1st.
4. Sectional will be played under the current BED's figures for classification. There will be five classifications: AA,A,B,C,D
5. Sectional qualification is open format.

CONSIDERATIONS FOR SEEDING

The Seeding of team will be based primarily on the following: strength of schedule, league record, non-league play, head to head competition, competition against other seeded teams and travel distances.

SITES

All 1st round games will be played at the school of the higher seeded team provided this field is determined to acceptable be the soccer committee. If the field of the higher seeded team is not acceptable, the game will be played at a site chosen by the higher seeded school.

The semi-finals and finals will be played at a neutral site selected by the soccer committee.

General Procedures for Sectional Contests

******IF YOUR SCHOOL SO CHOOSES- YOU HAVE THE OPTION OF NOT CHARGING AT THE GATE OF YOUR SECTIONAL GAME AND JUST PAYING THE OFFICIALS YOURSELF.**

If you have a site chairperson who is paid and if you do collect a gate- here are the procedures.

- 1) All schools in Section II are expected to make their facilities available for sectional play if so requested by the Section II sports coordinators. It is impossible to run sectional tournaments without the cooperation of the member schools. In any case when a sectional coordinator is not given permission to use a school's facilities for sectional play, the sectional Coordinator should register this information with the Section II president.
- 2) It is the responsibility of the Section II sport coordinator in each sport to provide the site chairman for his or her particular sectional activity with the information, form, etc. that he will need to conduct the sectional event.
- 3) Any expenses, which result from sectional activities, will be paid for by the Section II Treasurer. **IN ORDER FOR ANY EXPENSE TO BE PAID FROM SECTION II FUNDS; AN ORIGINAL SECTION II CLAIM FORM MUST ACCOMPANY THE INVOICE, BILL OR STATEMENT FOR THE EXPENSE. IF THE SECTION CLAIM FORM IS NOT COMPLETED, THE BILL WILL NOT BE PAID.**
- 4) At the end of each sectional event, it is the responsibility of the site chairman to complete the Section II financial report for the event and submit it with a check for admission fees to the Section II treasurer.
- 5) It is the responsibility of the sport coordinator to provide the section patches and plaques for the winning teams and individuals. These are ordered through the second vice-president of the section.
- 6) It is the responsibility of the site chairman to charge and collect an admission fee for all spectator sports which are played on the sectional level. The site chairman will also provide custodial services, supervision, ticket sellers, ticket takers, etc. These people will be paid by the section after completing a section claim form.
- 7) It is the responsibility of the section sport coordinator to provide officials for the contest (referees, umpires, etc.) This responsibility may be delegated to the site chairman if so desired.
- 8) All sectional contests will be conducted according to the NYS Public High School Athletic Association Handbook.
- 9) It is the responsibility of the site chairman to delegate a committee to handle appeals or protests at sectional contests.

10) Any questions regarding the management of sectional events should be directed to the sectional coordinator of the sport. When in doubt, ask!

Your league representative is your voice in the sectional play--- USE IT! BE REPRESENTED!

PROCEDURES FOR SECTIONALS

Responsibility of teams (coaches):

1. Provide score book (higher seeded team is official book)
2. Provide clock and horn (lower seeded team is official timer)
3. Provide two (2) linesmen (both teams)
4. Provide five (5) game balls (both teams). Five (5) like balls of the higher seeded team are to be use provided these are deemed acceptable by the referee.
5. Make sure there is no color conflict regarding game shirts. (Higher seeded team)
6. Clean up debris around bench area (both teams)
7. Provide a list of team members (max. of 24) for award presentation.
8. Report score (winning team)

AWARDS

1. Team awards: The first and second place team in each classification will receive a plaque.
2. Player awards: The players on the first place team of each classification will receive shields (25 white). The players on the runner-up team will receive shields also (25 maroon).

Remember, there are but 25 shields per team! The awards will be presented immediately after the final game. The coaches of the teams' participating in the finals are to bring a list of team members to the games to be placed at the scorer's table before the start of the game so the girls' names may be read at the end of the game for the award presentation. The committee would like these names read by a school officer from your school (principal, athletic director, etc.).

REPORTING SCORES

1. The winning coach should call the Sectional Soccer Chairperson as soon as possible following the game. New sites may need to be established. (518) 461-5082 cell
2. The winning coach should assume responsibility for game publicity. Please call the following numbers to report scores, and game information (who scored, assists, saves by keeper, team records etc.). Scores are to be reported! The news media tries to keep an accurate account of what is happening. Without our help, it is impossible. All the papers should be contacted and they will accept collect calls.

INFORMATION SHEET FOR HOST SCHOOL GIRL'S SOCCER SECTIONALS
*****YOUR SCHOOL MAY CHOOSE TO PAY FOR OFFICIALS AND NOT COLLECT AT THE GATE.**

The Athletic Director or Site Chairperson for the host school is asked to make provisions for the following:

1. Collecting money for spectators
2. Benches for players
3. Tables for timers and scorers
4. Chairs for the tables
5. Field clearly marked
6. Corner flags in place
7. Designate an area for spectators away from team area
8. Provide lavatory facilities for the teams

AND

9. Be prepared to meet the two (2) teams as they arrive and give them any special direction or information.
10. Be prepared to meet the officials when they arrive and have them complete vouchers.
11. Perform special duties required by the school.
12. Be available in case a doctor (ambulance) has to be called or for any special requests from the coaches. It is a good idea to tell the coaches in advance where you will be stationed during the game.
13. Get all vouchers together and send them to the Soccer Chairperson the next day! Vouchers should be clearly completed, signed by the Site Chairperson and sent to:

NYSPHSAA Yellow Card Accumulation Policy:

It is the intention of the NYSPHSAA Sportsmanship Committee to address the issue of the accumulation of Yellow Cards during the soccer season by an individual player/coach. The situations surrounding Red Cards are dealt with directly under the NYSPHSAA Guidelines for Sportsmanship and Misconducts outlined in the State Handbook for all sports.

The consequences for the accumulation of excessive Yellow Cards will be as follows:

1. Five Yellow Cards accumulated by a single player/coach in the regular season will result in a one game suspension. Disqualifications due to an accumulation of five yellow cards occurring in the last game of the season will carry over into the next season of participation, if the team does not enter post season play.
2. The continued accumulation of Yellow Cards by the same individual will result in a one game suspension per additional Yellow Card.
3. In the event that the player receives two Yellow Cards in the same game, resulting in a Red Card, the two Yellow Cards will not count toward the season total, since the player/coach will receive a one game suspension as a result of the misconduct and ejection.
4. The accumulation card total is for regular season play only and the process will start over again for post season play. However, any penalties awarded as a result of the last regular season game will carry over into the post season.
5. The post season policy will provide a one game suspension after three Yellow Cards and a one game suspension for each additional card received through the State Final. A one game suspension resulting from a yellow card in a team's last post season game will carry over into the next season of participation.
6. The coaches of both schools are to report all Yellow Cards to their League and Section by means of Mail, E-mail or Fax for tabulation. The officials should report to their boards concerning games in which cards are given and the reasons for issuance of the card. Board policy will determine the method of notification to the League and Section. A final end of the year report including data on disqualifications shall be sent to the NYSPHSAA Sportsmanship Coordinator.
7. Refusing to report, or failing to report infractions and allowing players/coaches to continue play/coach under these circumstances will result in the forfeiture of all games in which the individual in question participated.

All coaches in Section 2 are required to contact their league representative and Section 2 chairperson, Tom Husser, following every game that they have participated in where a card(s) has been issued. This needs to be done whether it was your team or the opponent that was issued the card. Information to be included should be date of game, team that the player issued the card(s) plays for, player's name, player's jersey number, and the card(s) received. This should be done the day of, or no later than the next school day after the contest. This policy is in effect for regular season play, sectional play and state tournament play.

2015 Rule Changes

3-3-3(e) New: Since the clock is stopped when bench personnel are cautioned or disqualified, substitutes from both teams who have already reported may be beckoned by the referee and may enter the field of play. Previously, there was no provision for substitutes to enter the field of play during this type of stoppage.

4-1-1(h)3: Currently, the jersey of the goalkeeper must be distinctly different in color from his/her teammates and opposing field players. To differentiate opponents, it is important that the goalkeeper's socks be included in this rule. Therefore, the goalkeeper's socks must differ in color from the opposing field players.

There are points of emphasis:

Points of Emphasis

1. Teams who are hosting a "Cancer Awareness" game are permitted to wear pink socks and jerseys. Visiting teams will wear their normal uniform.
2. Heat Acclimatization and Safety Priorities
3. Fighting/Reckless Play
4. Varsity and JV goalkeeper jerseys must have numbers on the front and back of the jersey. Front must be 4" and back number must be 8". Goalie number must be different from any other player on the field.
5. Tape or Similar Materials on Socks- Must be approximately the same color as the socks
6. Communication
7. Goal Kick
