

FAQ:

QUESTION – DO I HAVE TO CHARGE ADMISSION TO SECTIONAL CONTESTS?

ANSWER – ADMISSION MUST BE CHARGED FOR ALL SECTION 2 SEMI AND FINAL CONTESTS IN ALL SPORTS. OPENING ROUND AND QUARTER FINAL CONTESTS ADMISSION DOES NOT HAVE TO BE CHARGED **EXCEPT** FOOTBALL AND BOYS AND GIRLS BASKETBALL. FOR CONTESTS WHERE ADMISSION IS NOT CHARGED THE HOST SCHOOL IS TO PAY THE OFFICIALS. A SCHOOL MAY, IF THEY BELIEVE A LARGE CROWD IS EXPECTED, TO CHARGE ADMISSION FOR QUARTER FINAL CONTESTS.

WHEN ADMISSION IS CHARGED SECTION 2 WILL PAY THE EXPENSES ACCORDING TO CONTRACT (OFFICIALS) AND THE ESTABLISHED STAFFING AND FEE STRUCTURE.

QUESTION – WHERE DO I FIND THE REQUIRED FORMS WHEN HOSTING A SECTIONAL CONTEST?

ANSWER – THE SECTION 2 OFFICE WILL PROVIDE THE ATHLETIC EVENT CASH RECEIPT VOUCHER (PRE NUMBERED AND IN TRIPPLICATE), THE SECTION 2 SECTIONAL COMPETITION FINANCIAL REPORT (2 PAGES), A CONTEST OFFICIALS CLAIM FORM, AN EXPENSE CLAIM VOUCHER AND A W9.

QUESTION - WHERE DO I FIND THE REQUIRED FORMS WHEN HOSTING A REGIONAL CONTEST?

ANSWER – THE SECTION 2 OFFICE WILL PROVIDE THE ATHLETIC EVENT CASH RECEIPT VOUCHER (PRE NUMBERED AND IN TRIPPLICATE), THE SECTION 2 REGIONAL COMPETITION FINANCIAL REPORT (2 PAGES), A CONTEST OFFICIALS CLAIM FORM, AN EXPENSE CLAIM VOUCHER AND A W9.

QUESTION – DOES AN INDIVIDUAL NEED A W9 EVERY TIME THEY WORK?

ANSWER – NO, ONCE A W9 IS ON FILE WITH SECTION 2 THEY DO NOT NEED TO COMPLETE ANOTHER W9, THE ONLY EXCEPTION IS IF THEY MOVE. WE NEED THE CORRECT ADDRESS IF A 1099 IS REQUIRED.

QUESTION – WILL I RECEIVE A 1099 FOR MY TAX RETURN?

ANSWER – 1099'S ARE PREPARED AND MAILED IF THE INDIVIDUAL EARNS \$600.00 OR MORE IN A CALANDER YEAR, NOT THE SCHOOL YEAR. 1099'S ARE NOT ISSUED FOR EARNINGS OF LESS THAN \$600.00
